

# 2025 Cardinal Shooting Center - Shoot Vending

Our vending area for the trap events is located directly behind the trap line. This is a prime location since all events register at the CEB building and also provides easy access from all areas of the campground and ample parking nearby. Please visit [www.thecardinalcenter.com](http://www.thecardinalcenter.com) and click on "Map of Grounds" to view the diagrams of the trap line and campgrounds. *Note: This application does not apply to food vendors. Please contact Jake Spengler at 567-231-6086 for more information regarding becoming a food vendor for any of our events.*

Rates include a vendor spot with approximately 30' of frontage, and up to 125' deep, plus 20, 30, or 50 amp electric and water hook up close by. Fees include camping privileges on your vending spot. We will allow only one vending unit plus one camping unit per paid vendor spot. Please note: you may **NOT** camp on a vendor site if you do not have a vending license and station set up on your site. Honey dipping services will be available to purchase.

Vendors may begin setting up one day prior to the shoot date and tear down the day following the event. Contact the trap manager for leaving campers or vending trailers for additional days – additional fee required.

No sub-letting or sharing of vending spots during any of the events.

We **do not** have a shell house on the grounds; *shell vending is open to all vendors.*

A Certificate of Insurance with Cardinal Shooting Center listed as an additional insured **will be** required for **ALL** vendors at Cardinal Center; and must be provided prior to shoots.

An Ohio Vendor's License **is** required for **ALL** vendors on Cardinal Center grounds – please submit a copy to Cardinal Center with your shoot registrations. (State and County offices have made it clear that all vendors must have their vendor's license posted while on the grounds, as one or both offices will make unannounced spot checks during our shoots.) If you do not have a Morrow County, Ohio storefront, you will be required to purchase a Transient Vendors License from our County Auditor's Office.

After your initial arrival and setup, please keep all cars and tow vehicles **off** the grass. Personal vehicles should be parked on the gravel lot behind your respective vending sites. Thank you for your cooperation.

*Cardinal Center will do our best to accommodate your request but we reserve the right to assign all vendor locations.*

**CANCELLATION POLICY: Site money can be transferred to another event or refunded in full - if notice is given 30 days prior to event. All cancellations must be mailed to: The Cardinal Center, Trap Shoot Vending, PO Box 247, Marengo, Ohio 43334 and be postmarked 30 days prior to shoot!**

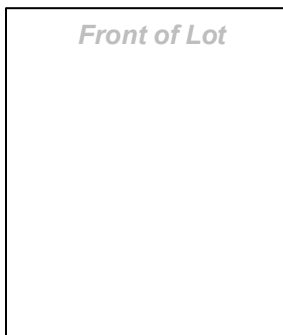
